Hope For The Central Valley to Age Well

Fresno County Department of Social Services

- DSS provides safety net services to over 500,000 Fresno County Residents
- Public assistance through Cal Works, Cal Fresh, General Relief, Medi-Cal determination and employment services and supports coordinated entry system in partnership with Fresno Madera Continuum of Care to support housing and homeless needs.
- Over 180,000 residents 60 years or older reside in Fresno County
- Each rural incorporated cities is home to at least 500 older adults, so there are 50,000 older adults living outside of the Fresno Metro service area

Adult Services Branch

- Adult Protective Services received over 4,000 reports of elder abuse in 2020.
- In Home Supportive Services Program serves over 21,731 recipients
- County Veterans Service Office serves over 4,000 veterans per year
- The Public Authority maintains a Registry of providers (891) to match with recipients who need a caregiver in IHSS.

Kathy Greenlee, Assistant Secretary for Aging, said that **self-neglect** is a sign of "not aging well because of a number of circumstances". She described that "over time certain things affect people and if they don't have the housing, support or money to take care of it, or they remain isolated, then it suddenly becomes a crisis situation."

She also said that APS can't do this work alone.

Poverty Rate: Implications to Aging Well


• National rate: 13.7%*

California rate: 15%*

- At 27%, Tulare County a central valley county has highest poverty rate in California *
- At 25 % Fresno County has second highest poverty rate in California, broken down, rural areas in general have a much higher rate*
- This can result in older adults needing to make painful and life impactful decisions on how to spend what little income they have to live on.
- While disability prevalence increases with age, cost burdened adults may not be able to afford to prepare or repair their home to address their needs which may further complicate their safety and well being.
 - These situations contribute to "self-neglect" types of referrals.
